#### LONDON

London is renowned as a hub for international legal careers, offering access to prestigious law firms and a robust global network. It's a prime destination for Antipodean lawyers seeking career advancement, higher salaries, proximity to Europe, and a vibrant cultural experience.

London firms typically seek lawyers with 4-6 years of NZ/AUS PQE, preferably from transactional or 'jurisdictionally mobile' practice areas, often with top-tier or international law firm experience.

## BENEFITS OF EACH MARKET FOR NZ LAWYERS

#### IRELAND

In recent years, Ireland, particularly Dublin, has emerged as a popular option post-Brexit and amid global shifts. The Irish legal market, dominated by five major firms, offers opportunities across practice areas such as tax, real estate, litigation, and employment law.

Highly interconnected with London and major European centres, Ireland is a global intersecting point attracting major transactions and legal activity. Irish firms prioritize work-life balance, manageable billable hours (around 1600 annually), and strong career advancement prospects, leading as leverage into other large markets e.g. London.

Irish firms typically prioritise NZ lawyers with 3+ years of experience, advantageously to those who have Irish passports/working rights.

#### ASIA PACIFIC

Asia Pacific, notably Singapore and Hong Kong, present as dynamic markets for lawyers aiming to establish themselves in major global economies. These cities host some of the world's largest law firms, offering substantial cross-border work opportunities in areas like transactional law, projects, construction, and international arbitration. With ongoing economic growth, particularly in Singapore, demand for skilled lawyers continues to rise. Similar to London, firms in Singapore tend to favour those with 4-6 years of NZ/AUS PQE, preferably from transactional or 'jurisdictionally mobile' practice areas, often with toptier or international law firm experience.
